Office Space Getting a Think-Over Working in the Post-Pandemic Neighborhood

The seven-story office building at 2550 M Street looks abandoned. For the past four months, only occasionally has anyone appeared in a window facing the street. Yet this is the Washington address of Squire Patton Boggs, one of the country's largest law firms, and a D.C. lobbying power-house since the Lyndon Johnson administration.

The lawyers are still working, but not at the office. The building has 207,081 square feet of Class A space, which in our neighborhood rents for \$52.63 per square foot per year. That's the average for the nine Class A buildings in the West End's sub-market. Office rental is our second largest industry.

Our top-flight space is not in much demand at present. Will it be a year from now, or two?

"It's the most uncertain market we've had in a generation," Adam Biberaj of Lincoln Property Company told the *Flyer*. His firm owns the renovated 2300 N Street building, now 85 per cent leased.

Another West End building, 2445 M Street, just

completed renovations on September 1st, after beefing up the tenant amenities, including a snazzy lounge area on the roof and a two-story fitness center. Plans to add

retail tenants, including Compass Coffee and a Union Kitchen mini-grocery are being rethought.

"In the post-Covid world, retail looks a lot differ-

Ballot Petition Challenge Filed in ANC-2A Election

The only contested election on the November ballot for the Foggy Bottom and West End Advisory Neighborhood Commission appeared to be in single-member-district 2A03, which is known as the

Foggy Bottom Historic District.

But will it be fought on the ballot? The race has already become interesting. In 2018, the incumbent commissioner, Trupti Patel, a 25th



Street resident, ran unopposed by successfully challenging her opponent's ballot petition signatures.

This year she has a potential opponent, John George, a long-time 26th Street resident. She has now challenged his petitions. The matter has not yet been settled at the D.C. Board of Elections.

For five of the seats on the unpaid, eight-mem-

ber commission, no one will be on the ballot. Write-in candidates are likely to emerge. Meanwhile, ANC-2A is getting smaller. A second member has left before the end of the two-year term which runs to December 31.

William Kennedy Smith, who had represented the Watergate area well since 2015, resigned on August 22nd stating that he no longer resides in the 2A04 district. A nephew of former President John F. Kennedy, Smith has not sold his family's spacious Watergate apartment, but has moved to their country house in Maryland for the school year, friends tell the *Flyer*.

One relatively new West End homeowner has qualified for a higher office on the same November ballot. Kamala Harris and her husband bought a unit at the Westlight Condominium on 24th Street in 2017. She is running for Vice President of the United States.

West End Restaurants and Retail Getting Support

"We all thrive if we support one another," was the subject line of an August email from Jeri Epstein to her West End neighbors. An attachment listed 14 restaurants where they could get take-out food.

Since January 2019, Epstein has been the Advisory Neighborhood Commissioner for the 2A06 district, which is the eastern half of the West End.

She agreed to update her list for inclusion in a two-page "Listings" section in this issue of the *Flyer*, which also includes other businesses and services.

The idea is to remind neighbors that there is an interdependency with our local businesses, which provide needed services and employment.

We've been glad to see Ris Lacoste and other top restaurateurs stay open, and we welcome Chef Geoff and the new Tatte Bakery and Café that opened August 26 in the former Meiwah space. (See photo at right and listings section.) It is tough to run a business now.

Our neighborhood has never had a vibrant business improvement organization. Epstein and others are beginning to discuss forming one. The Covid 19 situation has spurred interest as well as the realization

that local retail is more crucial now that everyone is staying closer to home.

ent," says Shane McLaughlin, of Beacon Capital Partners. "We are working with our retail partners to find the best use to service the building and neighborhood."

Two years ago, Lincoln Property also announced it would have a restaurant at its 2300 N Street building, at the corner of 24th and N Streets, with a "rosé wine garden" on a patio. That has not happened yet.

Both companies may be fortunate, however, to be able to rethink first-floor retail space now—and their unleased space upstairs—to fit the new reality.

KMPG, the international management consulting firm, released a survey on August 24, indicating that 69 per cent of global CEOs agree with the statement: "We will be downsizing office space."

Ford Motor Company recently told everyone at its Dearborn, Michigan, headquarters to clean out their desks and take their possessions home so it can redo office layouts for the new era. The days of commuting to the office five days a week may already be over.

On the other side of the West End, at 2050 M Street, a shiny new 11-story Tishman Speyer office building is also open now, with 336,000 square feet. It, too, has a ritzy roof lounge, a high-end fitness center,

other Class A amenities-and unleased space.

Its anchor tenant, the Paul Hastings law firm, founded in Los Angeles in 1951, took four floors and began moving in around the first of March. Most of its lawyers are now working from home.

With decision-making spread out among corporate brass, state governments, and local school districts, small and large businesses alike are not in a hurry to "repopulate" empty offices, and are even less eager to sign new leases or implement former plans.

Office space "hasn't taken nearly the hit as retail," says Kari Blanco, a property manager for Washington REIT. "But nobody has a crystal ball for this."
